FINAL JUDGMENT

On the 15th day of October, 2021 came on to be heard the above-entitled and numbered cause. The Plaintiff, Valerie Alvarado, appeared in person, by video conference and the minor Plaintiff, A.G., appeared, by Next Friend, and by Christina Melton Crain who had previously been appointed by the Court as Guardian Ad Litem for said minor Plaintiff.

The Plaintiff, Miguel Santos, appeared in person, by video conference and the minor Plaintiff, A.G., appeared, by Next Friend, and by The Stradley Law Firm, Mark E. Stradley who had previously been appointed by the Court as Guardian Ad Litem for said minor Plaintiff.

Defendant, JACOB BARNETT, appeared by and through counsel of record.

The Court was informed that all matters in controversy between the Plaintiff and the Defendant have been compromised and settled by agreement; whereby Defendant agrees to pay to Valerie Alvarado, INDIVIDUALLY AND AS NEXT FRIEND OF A.G., the total sum of FOUR THOUSAND FOUR HUNDRED THIRTY FIVE Dollars and 91/100 (\$4,435.91) out of

CC - 20 - 04782 - A CFJ FINAL JUDGMENT 2515628 which all attorney's fees, medical expenses and hospital liens, costs and expenses of all types shall be paid; to be disbursed as follows:

Defendant agrees to pay LAW OFFICES OF DOMINGO A. GARCIA, P.C. the sum of ONE THOUSAND FIVE HUNDRED SEVENTY ONE DOLLARS AND 30/100 (\$1,571.30) on behalf of A.G., a minor for attorney's fees and costs.

Defendant agrees to pay the total sum of EIGHT HUNDRED THIRTY SEVEN DOLLARS AND 73/100 (\$837.73) payable to the LAW OFFICES OF DOMINGO A. GARCIA, P.C, to pay for all liens and medical expenses for A.G., a minor.

Defendant agrees to pay the total sum of TWO THOUSAND TWENTY SIX DOLLARS AND 88/100 (\$2,026.88) payable to the County Clerk of Dallas County, Texas for the use and benefit of A.G., a minor, free and clear of all expenses, fees and costs.

Defendants agree to pay to MIGUEL SANTOS, INDIVIUALLY AND AS NEXT FRIEND OF A.S., the total sum off SEVEN THOUSAND ONE HUNDRED FIFTY THREE DOLLARS AND 99/100 dollars (\$7,153.99) out of which all attorney's fee, costs and expenses of all typed shall be paid to be disbursed as follows:

Defendant agrees to pay LAW OFFICES OF DOMINGO A. GARCIA, P.C. the sum of TWO THOUSAND FOUR HUNDRED NINETY THREE DOLLARS and 60/100 (\$2,493.60) on behalf of A.S., a minor for attorney's fees and costs.

Defendant agrees to pay the total sum of ONE THOUSAND TWO HUNDRED FIFTEEN DOLLARS and 56/100 (\$1,215.56) payable to LAW OFFICES OF DOMINGO A. GARCIA, P.C., to pay all liens and medical expenses for A.S. a minor.

Defendant agrees to pay the total sum of THREE THOUSAND FOUR HUNDRED FOURTY FOUR DOLLARS and 83/100 (\$3,444.83) payable to the County Clerk of Dallas County, Texas for the use and benefit of A.S., a minor, free and clear of all expenses, fees and costs.

Defendant agrees to pay the court costs herein.

A jury having been waived, the Court read the pleadings, heard the evidence and remarks of counsel and of the parties hereto, inquired into the facts and circumstances concerning the settlement and incident in question and concerning the injuries and damages to the minor

Plaintiff, and other evidence deemed by the Court necessary to make a determination of the fairness of the settlement, and found that the settlement should be approved and that such agreement is in the best interest of the said minor Plaintiff and should be in all things approved and be apportioned as set forth above.

It is THEREFORE, ORDERED, ADJUDGED and DECREED by the Court that the settlement between the Plaintiffs and Defendant be, and the same is hereby, APPROVED

It is further ORDERED, ADJUDGED and DECREED by the Court that the County Clerk of DALLAS County, Texas, is hereby ordered, directed and authorized to invest the funds paid on behalf of the minor Plaintiffs, A.G. and A.S., in a federally-insured, interest-bearing account at County Clerk of Dallas county, Texas, for the use and benefit of A.G. and A.S.; until the minors reach majority, or until the Clerk of this Court is supplied with a letter of guardianship of the estate of the minors, or until the posting of a valid bond in double the sum paid to the Clerk of the Court, or until further order of the Court upon good cause, at which time the Clerk shall

pay the sum to the appropriate person without further court intervention. All statements of Minor A.G.'s account shall be sent to Valerie Alvarado. All statement of minor, A.S.'s account shall be sent to Miguel Santos

It is further ORDERED, ADJUDGED and DECREED that said Judgment is fully and finally in all things approved and that same be entered as having been fully satisfied, and no execution shall issue on this Judgment.

It is further ORDERED, ADJUDGED and DECREED by the Court that this Judgment and the amount to be paid hereunder shall bear no interest.

By the parties' signatures or by their attorneys' signatures on the Judgment, all parties to this cause of action hereby waive all of their rights to appeal this Judgment.

It is further ORDERED, ADJUDGED and DECREED by the Court that any and all relief not specifically granted herein is hereby denied.
